Darul Uloom Deoband asks Saudi Arabia to rethink decision

AYODHYA: Islamic seminary Darul Uloom Deoband has condemned the reported decision of Saudi Arabia to ban Islamic missionary movement Tablighi Jamaat after denouncing it as a "gateway of terrorism".

Chief rector of the seminary, Maulana Abul Qasim Nomani, has asked Saudi Arabia to rethink its decision, saying otherwise a wrong message may be conveyed to Muslims. This is for the first time that the Islamic seminary of Deoband has openly condemned the Saudi government. The religious affairs ministry of Saudi Arabia had recently dubbed the Tablighi Jamaat as a gateway of terrorism and banned it.

Prominent Muslim activist

surprised by the decision of Saudi Arabia as the Tabligi Jamaat was always an antidote to any extremist idea. The Jamaat maintained its disapproval of all modern Jihadi movements. Even the Taliban has spoken many times against the Tablighi Jamaat". Saudi Arabia's description of the Tablighi as a gateway of terrorism is unbelievable and unacceptable, he said. In a video message from the UK, Sameeruddin Qasmi, spokesperson of the Tabligi Jamaat of Hazrat Nizamuddin Markaz, said, "It is a big allegation on the Tabligi Jamaat. It has no connection with terrorism. Tablighi Jamaat is the group that stops terrorism, condemn terand country. We talk only for five pillars of Islam, none of our men have ever been found involved in any terrorist activities," he asserted. "The Saudi government might

have been mislead," he added. Mohammad Miyan, a member of one of the factions of the Jamaat, said, "Our Jamaats are working all over the world. Even in Saudi Arabia, Jamaat members are working to bring the Muslims on the right path as taught by the Prophet. We will not comment over the decision of Saudi government, but our Jamaats will continue to work in Saudi Arabia." Maulana Fakhrul Hasan Khan, a senior faculty in Darul Uloom Nadwa, said, "We have received the news only through the media. We will contact our people in Saudi Arabia before reaching any conclusion.'

Battle for east UP hots up as BSP, BJP MLAs join SP

LUCKNOW: The battle for 2022 assembly elections in eastern region of Uttar Pradesh (UP) is getting interesting. Influential Bahujan Samaj

Party's (BSP) Brahmin leaders from east ÚP Vinay Shankar Tiwari (sitting MLA) Kushal Tiwari (ex-MP) and Ganesh Shankar Pandey (former chair-person of UP Legislative Council) along with the Bharativa Janata Party (BJP) MLA from Khalilabad seat in Sant Kabir Nagar Digvijay Narain Chaubey ioined the Samaiwadi Party in the presence of the SP chief Akhilesh Yadav at the SP state headquarters in Lucknow on Sunday.

The BSP had already expelled Vinay, Kushal, and Ganesh last week after it was clear that the three were set to join the SP. Through these leaders the SP

is expecting consolidation of Brahmin votes in east UP. Vinay Shankar Tiwari, son of

Samajwadi Party's banner put up on the roadside in Lucknow.

Hari Shankar Tiwari, is an MLA from Chillupar constituency, Kushal is a former MP from Sant Kabir Nagar, whereas Ganesh Shankar Pandey was the chairman of the Legislative Council at the time of the BSP government. Vinay and Kushal are the

sons of influential eastern UP leaders from Gorakhpur, Harishankar Tiwari while Ganesh is a nephew of Hari Shankar Tiwari. Speculation is rife that Haris-

hankar too would join the SP soon. Hari Shankar Tiwari was the first public figure in Indian political history to be elected to

the legislature from prison. Elected from Chillupar for the first time in 1985, he remained a member of the legislative assembly for 23 years uninterrupted. Tiwari is known face of brahmin politics in UP. He had been a cabinet minis-

ter in UP in BJP, BSP, and SP governments. Earlier in October, six sus-

pended BSP MLAs joined Samajwadi Party in the presence of party chief Akhilesh Yadav in Lucknow. These MLAs include Hargovind Bhargav, Mujtaba Siddiqui, Hakim Lal Bind, Aslam Raini, Sushma Patel and Aslam Chaudhary. Uttar Pradesh is scheduled to

go for Assembly polls in 2022. Previously, in the 2017 Assembly elections in Uttar Pradesh, the BJP bagged 312 seats out of the 403-seat Uttar Pradesh Assembly while the SP bagged 47 seats, BSP won 19 and Congress could manage to win only seven seats. The rest of the seats were bagged by other can-

CROP DAMAGE: UP **ALLOCATES RS 535** CR UNDER SDRF

LUCKNOW: The Uttar Pradesh government has allocated approximately Rs 535 crores under State Disaster Response Fund (SDRF) to farmers who suffered crop loss owing to recent floods in financial year 2021-22 As many as 15 lakh farmers will benefit under the scheme.

Additional chief secretary rural development and panchayati raj, Manoj Kumar Singh said in a press statement on Sunday that after an assessment of crop losses, the government pegged the crop loss in the state at around Rs 5,34,94,38,981. The state government had released the compensation to around 15,26,351 farmers and the district collectors would distribute it through DBT, he said.

On Saturday, the state government released an installment of Rs 63.16 crore to be distributed as relief to over 1, 82,731 farmers affected by the flood. Earlier, the government had released Rs 471.77 crore in installments. Singh said. The crops were damaged due to rain and floods in

September and early October.

Owaisi asks if Akhilesh would appoint Muslim deputy CM in case SP wins UP polls

KANPUR: AIMIM chief Asaddudin Owaisi on Sunday asked Samajwadi Party chief Akhilesh Yadav if he would appoint a Muslim for the post of deputy chief minister of Uttar Pradesh in case his party wins the state

assembly polls. Addressing a public rally here in Kanpur, Owaisi said, "Do not care who will be chief minister of Uttar Pradesh. If Samaiwadi

Party wins the UP polls, will its chief Akhilesh Yadav appoint a Muslim Deputy CM?" The AIMIM chief said his

party will contest 100 seats in the upcoming Uttar Pradesh elections. He said AIMIM is open to forming an alliance.

He added, "My Masjid (Babri) was demolished. People who demolished it, disrupted the foundation of India and the rule

of law...Did anyone from SP, BSP or Congress say anything? They turned a blind eye as my Masjid was demolished but not theirs.'
