This has reference to the Company's disclosure dated December 31, 2025 filed under Regulation 30 of the SEBI Listing Regulations w.r.t. receipt of certain orders from the income tax department.

In this regard, we wish to inform that the company had preferred rectification application against certain tax demands raised by the Income Tax Department for Assessment Year 2020-21. Pursuant to rectification orders received, tax demand of Rs. 22.10 crores stands deleted in its entirety. The appeal on merit ground is being pursued before ITAT separately.
